Overview

Purpose

We are providing shipboard guidance to research vessel data managers to expedite onboarding of new personnel and equipment/data setup. By ensuring consistency between vessels, cruises and samples of recorded datasets, post sampling processes and analysis can be accelerated. In this document we discuss the data flow, organization, and processing of shipboard digital data.

Who we are

The Subsurface Monitoring Unit (SMU) is an umbrella group built to coordinate research vessel activity in the Gulf of Mexico relating to the MC252 incident. Our goal is to provide ship coordination and data management between the research fleet and Incident Command (plus all other interested parties.)

Who YOU are (the Data Manager)

The data manager on the ship has several very important roles that differentiate them from the sample manager (who physically takes water samples.) Your role includes:

- Generation and delivery of the "Daily Deliverables"
- Data uploads to ftp (including raw data) for archiving
- Recording information in the sample log sheets
- Sample ID generation (labels for bottles)
- General assistant to water sampling team

Policy

All observational data will be routed through the Data Processing Workflow, to include (at a minimum) quality assurance and quality control (QA/QC) steps, model ingestion (where relevant), and analysis by the Joint Analysis Group (JAG).

Approach

Data management is a critical part of the overall sampling strategy. The basic approach is to aggregate validated sampling data via direction from the UAC. This effort will be directed by the NOAA SSC at the area command. All observations that are developed under this overall plan will be transmitted to a NOAA-managed SFTP server at the area command and then transmitted to the assigned modeling groups. This will establish an "authoritative source" and chain of custody for data, so that modeling efforts will maintain consistency and reliability. Subsurface data can also be integrated with surface observations, shoreline data, and atmospheric


conditions.

Modeling output can also be transferred via this SFTP service, but will most effectively be managed by the modeling groups directly due to file size and format specifications. Alignment with the unified command priorities and incident command needs is critical. With numerous vessels, platforms, and activities in the region the operational unit leaders need to be made aware of any new sampling efforts or equipment being deployed. Informational updates will be provided on a daily basis to ensure the security and integrity of the sub-surface cruises.

Numerous organizations are keenly interested in receiving timely shipboard data (CTD and LISST) for analysis. Currently, this data is being delivered in numerous formats using a number of delivery channels which is complicating the preparation of the data for analysis.

In order to accelerate the analysis and the decision making process related to the CTD and LISST data, a consistent data file format is required for both sets of data. This document lays out a data specification for the consistent creation of the CTD and LISST data in Appendix 3.

SOPs (Standard Operating Procedures) are available, such as clean sampling techniques and decontamination procedures, as part of the cruise plan.



STEP 1: Before the Cruise

Let us know you are heading out!

Before the cruise begins, the Data Management Coordinator must email the following information about themselves to epadwh@gmail.com:

- Name
- Name of Vessel
- Email Address
- Satellite Phone Number on Board the Vessel (can be delivered upon arrival to vessel)
- Cell Phone Number
- Start Date of Cruise
- Projected End Date of Cruise

Gathering forms

When we are able to contact you, we can build a log book with you, and give you a 1TB hard drive with a pre-made file structure to organize your data (explained more in Appendix 1: Organization of Data During the Cruise.) This will be important to receive the correct sampling sheets, COCs, paperwork and contacts that will help facilitate the processing, integration, and analysis of the cruise data. The set of forms you will need in your log book are:

- This Document (Guidance for Shipboard Data Management Coordinator)
- Locations Template + example
- Sample Template + example
- Rototox Template + example
- Blank COC forms/labels for sample bottles

<u>The</u> Data archive for all research ships. If you have connectivity, you can find all other ships data here & upload your data in near real time. See Appendix 1 for more login help, and email the SMU for login information.

Daily Deliverables

Daily data packages should be submitted to <u>epadwh@gmail.com</u> by **midnight central time**. These data packages must include the following deliverables:

- 1. Detailed Status Report (Required)
- 2. Data Table of Sampling/Monitoring Locations (Required)
- 3. Data Table of Sampling Information (Required)
- 4. Annotated CTD Plots (Required)
- 5. Processed CTD .asc files (if sufficient internet connectivity, see Appendix 3: Processing CTD data for more instructions)
- 6. Data Table of Rototoxicity Test Results (Optional)
- 7. LISST Particle Analysis Report (Optional)
- 8. Map if vessel provides (Optional)

Data packages will be compared against the requirements described in this document as well as the field description tab of each data entry template. If deliverables within a given data package do not meet these requirements, an email will be sent to the offending Data Management Coordinator. Such emails will provide some indication of the reason why the deliverable is being rejected. Emails will also be sent to relevant Data Management Coordinators who miss a deadline and/or fail to provide complete data packages.

The SMART team will upload the daily deliverables to the folder "CURRENT_CRUISE" under a date folder (YYYY_MMDD) for the deliverables on a daily bases - this is at the root of the ship folder.

CTD Sampling

For timely analysis during the cruise (if you have internet connectivity) please process the CTD data in the specified format and include in the daily deliverables (See Appendices). The data should be provided in a text format e.g. csv or asc. The complete .hex and .con files are not part of the daily deliverables.

STEP 3: After your cruise

Uploading Complete Data Set (must include raw data)

After each cruise, load the entire "Cruise#_MMDD-MMDD" folder on to the ftp site: **sftp.orr.noaa.gov/Deepwater_Horizon_Int/Subsurface_Monitoring/Your_Ships_Name** This folder structure and a single hard drive can be used during the cruise so that data distribution between all parties can receive copies easily after the cruise. You can release your log book to the Subsurface Monitoring Unit - room 310, first table (remember that the physical log book will have a Chain of Custody!)

If you have a good internet connection on your ship you can upload data directly to the sftp OR&R site in the folder structure as you receive it. This is the preferred method, since we will be able to see more data closer to real time. (See Appendix 3 on FTP instructions, and email the SMU for login information.)

Pass the Baton

Find out who is the next data manager for your ship, and get in contact with them! Give them this packet, and any information that you found important during your cruise.

Appendix 1 – Organization of Data During the Cruise

File naming convention

Within the FTP folder, each vessel has its own folder under which individual folders for the CTD, LISST and Location data has been created.

Data created in each folder must have the following format:

<DATA_TYPE>_<VESSEL_CODE>_<DATE>_<CRUISE_NUMBER>_<Station_ID>

<DATA_TYPE> = "CTD", "LISST", "LOC"

<VESSEL_CODE> = "BM", "OV", "RC"

<DATE> = MMDDYYYY


Note: that if a sample is repeated at a given location then this sample should be uniquely identified from the original sample by the date and time assigned to each.


Folder Structure for CTD / LISST / Pictures / etc.

Basic folder structure for each cruise is shown at the right & below.

The SMART team will upload the daily deliverables to the folder "CURRENT CRUISE" under a date folder (YYYY MMDD) for the Subsurface Monitoring revised deliverables on a daily bases - this is at the 06/10/2010 Cruise Data Organization Brooks_McCall root of the ship folder. The cruise data CURRENT_CRUISE manager will save the daily deliverables sent YYYY_MMDD *The Deliverables* under Documents > Daily_Deliverables > Cruise_01 Data Collection YYYY MMDD > *the documents*. (These will be Sample_Logs log books near duplicates, but the SMART team usually has Station ID to tweak small changes sent to them before CTD YYYY_MMDD_SID *the data* uploading into the SCRIBE database, so it is LISST important to keep all versions of the data.) Discrete YYYY MMDD SID Sample Logs (under Data Collection) will be the Continuous location for storing the xls files of samples YYYY MMDD SID Photos_Videos collected/stations/etc - your log books. YYYY_MMDD *the data*

Each ship will have a folder, containing each cruise. The cruise data will be divided up by the *Data_Collection* and *Documentation*. Most of the data will be sorted in the *Data_Collection* folder by **instrument** > **date-station ID** > **data file** (Except for continuous data/transects, which should be under a just-date folder.) Each Instrument should have its own sensor folder!






Explanation of Sampling Scheme

Appendix 2 – Descriptions of Required Daily Deliverables

Example files and templates should be included on your hard drive, and are also located on the OR&R SFTP site.

Deliverable: Detailed Status Report

Description: A concise log and report of the vessels activities during a 24-hour operating period. Include a summary of ongoing Rototoxicity tests (what test are ongoing, what is the progress, etc).

Description: A spreadsheet that documents the samples that were collected at specific locations and depths. This should be a cumulative log for the entire cruise (do not delete what was reported the previous day).

Deliverable: Annotated CTD Plots

Recommended method: 1) Import the .jpg generated by the Seabird software into Microsoft PowerPoint. 2) Add the annotations. 3) Save the file as a JPEG File Interchange Format.

Image Formatting

In order to analyze and process the CTD deliverable from different vessels and different CTD setups, this framework aims to provide consistent parameters for generation of the plot and its annotation for the data manager to deliver back to the Deep Water Integrated Oceans Operations team (through epadwh@gmail.com).

Check in with the CTD operator/engineering technician aboard the vessel concerning...

X-Axis Variables and Parameters

These variables and their ranges shown in the plot need to be consistent. This information can be programmed into the SeaBird processing software.

Variable	Units	Axis minimum	Axis maximum
Fluorescence	mg/m³	0	50
Dissolved Oxygen	mg/L	0	20
Temperature	deg C	0	26
Salinity	PSU	32	37

Downscan

For ease of viewing and the smoothest data scan, only the downscan of each of the above variables should be included in the plot. This can be accomplished by splitting the data and generating the plot or stopping the plot generation at the maximum depth. Note: this is only for the purpose of generating a clean deliverable; the sensor data should be recorded for the CTD's trip through the water column as decided by the Chief Scientist and those in charge of mission planning.

Annotation Requirements


Please add an annotation tag to each plot in Microsoft Powerpoint (or other suitable software), and save the plot tied to the annotation as a JPEG image. This tag should include only the following information:

- "CTD Raw Data"
- StationID
- Date
- Latitude
- Longitude

Save this powerpoint slide as a JPEG image and include one for each station in the daily deliverable package.

Metadata

To provide adequate background information on data collected during your cruise, we need "data about data". This includes basic information for a minimal metadata record.

Most of this information is can be produced by the technician of the instrument. (For example, the CTD header file is updated before every cast with some basic metadata – see the shipboard data processing section for those requirements.)

Please make sure you have this set of information for each instrument, for each raw data file produced:

- Person to contact about the data, and their contact information (most likely the data manager, maybe the tech)
- Instrument used
- Time/Location of data collection
- Processing steps

Appendix 3 – Shipboard Data Processing

Vessel "Source" Format

The table below details CTD instrumentation setup and detail data specification for the Sea-Bird software. Configuring the CTD scan using these parameters will ensure consistency in data analysis between cruises and between vessels.

It is important to ensure that the parameters specified here are configured exactly as detailed e.g. the order of the "name" fields is important so that this data can be mapped to the target specification.

LISST Sampling

In reviewing LISST data samples from both the Ocean Veritas and the Brooks McCall and determining that they were using the same format, the data format detailed below was adopted, eliminating the need for either vessel to change their formatting.

Within the data format there are 32 size ranges logarithmically placed form 2.5 - 500 microns (the upper size in each bin is 1.180 times the lower). The numbers in columns A through AF shows the median size of each size class.

Processing the Data for Daily Reports:

The volume concentrations from columns A-S (2.5 to 53.5µm) is summed for each of the first twenty rows and averaged.
