Survey objectives

There were two primary objectives to conducting this survey. The impetus for the survey was to provide background information to inform a social marketing campaign regarding littering in Saipan, with a potential focus on LaoLao Bay. Because surveys are time and resource intensive, local resource agencies in CNMI as well as the National Oceanic and Atmospheric Administration (NOAA) Coral Reef Conservation Program used the opportunity to collect information on knowledge, attitudes and perceptions of coral reefs and coral reef management strategies.

Market Research and Development, Inc. (MRD), a Guam-based survey firm, was contracted to implement the survey. MRD had conducted a coral reef awareness study for CNMI in 2007. Where feasible, results were compared between the 2007 and 2011 studies.

Survey development

In developing the Saipan Coral Reef Survey, numerous agencies and organizations were asked for input. First, a one-pager about the survey was developed and circulated among partners in October 2010. Representatives from SeaWeb and NOAA met with agency partners, including CNMI Division of Environmental Quality (DEQ), CNMI Coastal Resources Management (CRM), CNMI Division of Fish and Wildlife (DFW), in October to get initial input on the survey. Second, a draft survey topic list (see Appendix B) was developed by NOAA and DEQ and circulated to the following organizations in January 2011: DEQ, CRM, DFW, Mariana Islands Nature Alliance (MINA), SeaWeb, Edge Consulting, National Oceanic and Atmospheric Administration (NOAA). In February 2011, two focus groups were designed by SeaWeb and Edge Consulting and conducted by DEQ to get input on an initial list of campaign topics and messages. Based on comments from partner organizations and the focus groups, the topic list was amended and used as a basis for developing a questionnaire. The draft questionnaire was circulated to the same group of organizations in late February 2011 and, when requested, in person meetings were held to discuss the survey. The questionnaire was finalized in early March 2011 based on comments from partner organizations and is provided in Appendix C.

Methodology

The survey was conducted from March 7 to March 22, 2011. 522 respondents completed the survey via telephone interview. The respondents were residents of Saipan who were:

- 18 years of age or older;
- Lived in traditional households (e.g. apartments, condominiums, and single family dwellings), and;

• Had a listed landline telephone number.

All efforts were made by MRD to ensure a representative sample of the Saipan population. With a population of 48,317 in 2010 (estimated), the minimum sample size is 381 respondents (95% confidence level and 5% confidence interval). The survey was offered in English, Tagalog, Chamorro, and Carolinian. Of the 522 respondents, 508 chose to take it in English, three in Tagalog, eight in Chamorro, and three in Carolinian. Several other languages are commonly spoken in Saipan, including Chinese and Korean; however, due to limited resources, the survey was only offered in the four primary languages spoken. It is not known whether any potential respondents refused because their language was not offered.

Selected Results and Discussion

For a full listing of the results of the survey, please see Appendix 4, which includes all questions asked and all summary statistics for the responses. Selected results are presented below.

The first few questions asked generally about all issues facing Saipan and the importance of environmental issues in particular. When asked an open-ended question (that is, answer choices were not provided) about major issues facing in Saipan, three out of four mentioned something about the economy, jobs, and/or unemployment.

- Five percent mentioned the environment or climate change.
- Three percent were also concerned about the coral reef threat.
- An additional 2% were concerned about recycling or littering.

Concern about water pollution, coral reef threat, environment/climate change, and recycling/littering all increased from 2007. About 90% of respondents stated that environmental issues are "very important" to them. As compared to 2007, 89% of respondents stated that environmental issues and "very important" to them- so there has been no major change from 2007 in perceived importance of environmental issues. Saipan residents continue to perceive the environment as very important. See Appendix 4 for full responses.




Figure 1: Participation in coastal and marine activities in Saipan within past 12 months (n=522)

The next few questions asked about participation in coastal and marine activities over the past 12 months. As shown in Figure 1, the most popular activities are "picnics/barbecues" (84%) and "walking/hiking/running (82%)." Over a third also mentioned that they fish. "Other" activities mentioned by respondents but not included in the survey list include volleyball, sailing, canoeing, and boogie boarding.




Figure 2: Reasons for fishing among those who indicated that they fish (n=182)

Of those who fished, nearly three-fourths did so in order to catch fish to eat, as shown in Figure 2.

To get a sense of beach use and beach popularity, the next question asked which beaches were visited during the past year. This question was included to understand the use of LaoLao Bay relative to other beaches and potentially provide information to inform future campaigns. Over half of Saipan residents have visited Micro Beach in the past year. It is also the most popular beach

location, with 27% noting it as the one they visited most often. Only one fifth of respondents had visited LaoLao Bay, with only 4% saying LaoLao was the beach they visit most often.




Figure 3: Popularity of Saipan beaches (n=522)

In response to a question on perceptions of the conditions of Saipan's marine resources, residents are most likely to notice an increase in:

- Litter on beaches: Sixty-one percent say it has either increased (22%) or increased a great deal (39%).
- Water Pollution: Fifty-seven percent say it has either increased (21%) or increased a great deal (36%).
- They are more likely to be aware of decrease in the abundance and size of fish.


These results suggest that residents' perceive the marine environment to be getting worse over time. Perceptions such as these can form the basis for increased management actions related to the marine environment and should precipitate resident support for such management actions, such as increased enforcement of existing laws, additional education and outreach campaigns, or new regulations to conserve marine resources.


As shown in Figure 4, residents were least likely to be aware of changes in the "number of sharks," "sedimentation," and "algae growth". This may be due to many residents' limited ability to view these changes on a daily basis (as opposed to litter, which is visible on beaches). However, they are also significantly more likely to notice changes regarding litter on beaches, water pollution, and the size and abundance of fish – for these variables, less than 10% stated that they "didn't know."





Saipan residents are most likely by far to base any ratings regarding the coral reef environment on their "personal experience."





Respondents were next asked about their knowledge of Saipan's marine resource rules and regulations. As shown in Table 2, respondents indicated high confusion and misunderstanding of Saipan's rules, in some cases thinking that rules were more restrictive than they are and in other cases thinking they are less restrictive than they are. For example, only 24% of respondents correctly answered that scuba diving is allowed everywhere in Saipan, with the other 76% of people thinking it's restricted in some areas, requires a permit, is not allowed at all, or they didn't know. However, eighty-four percent correctly believe that "taking of live coral" is not at all allowed in Saipan. People are least likely to be aware of whether or not "collecting and harvesting trochus" is legal, with 23% responding that they didn't know whether it was legal or not.

When asked to name three of the top threats to the coral reef environment, residents were most likely to mention issues related to **pollution (**littering, illegal dumping, and erosion/runoff) and f**ishing practices** (illegal fishing, harmful fishing practices, too much fishing).





Figure 6: Perceived threats to the coral reef environment (n=521)

When asked about support for or opposition to marine management measures intended to improve coral reef health, respondents were in favor of ten out of the 11 measures mentioned, with only limiting dive tourism not receiving a plurality of votes.





When asked about ways of reducing the number of plastic bags on island, people were most likely to support a campaign for reusable bags; however, a majority of respondents would also support either a fee for plastic bags or an outright ban on them in Saipan.





Figure 8: Support for and opposition to ways of reducing plastic bag use in Saipan

In order to gain an understanding of the frequency that certain actions that are damaging to coral reef ecosystems occur, residents were asked whether or not they had seen or heard of anyone doing a list of activities during the preceding year. The question was asked in this way to be non-intrusive so that people felt free to answer without incriminating themselves. While it is assumed that not all respondents answered this question truthfully, we also assume that the percentage of those not being truthful will remain the same over time such that this question could be asked again in the future to get a sense of whether these damaging behaviors are increasing or decreasing over time. Over three quarters of respondents had seen someone littering on or near the beach. About a quarter of respondents had seen or heard of others breaking fishing restrictions, including using gill nets, fishing in the MPAs and catching or eating sea turtles.

In order to gage how many of Saipan's residents litter and what littering actions they may take, respondents were asked directly whether they had littered in the past month. In total, 53% of respondents admitted to littering. When asked about their own behavior regarding littering, residents are most likely to mention dropping "gum or candy wrappers," "dropping a cigarette butt," or "spitting betel nut on the ground." Of those who littered (n=278), 37% indicated having done so at the beach. Nineteen percent of all respondents (n=522) indicated having littered at the beach

As shown in Table 3, residents are more likely to litter when they are: "holding something biodegradable," (35%), "in a hurry" (15%), or "the trash cans are already full" (16%).

Table 4 shows the results of a series of statements about littering. For the social marketing campaign, it is important to note the resonance of beach and marine related comments. In particular,

- 94% of respondents agree or strongly agree that "litter that accumulates on our beaches will discourage tourists and hurt our economy."
- 93% of respondents agree or strongly agree that "litter that accumulates on our beaches is a bad reflection on us as Saipan residents."
- 93% of respondents agree or strongly agree that "litter causes harm to marine life."
- 88% of respondents agree or strongly agree that "littering is a problem on Saipan beaches."

Respondents are most likely to **strongly disagree** with:

- "Littering is not a big deal because someone (like DPW) will pick it up."
- "Cigarette butts are not litter."
- "If others litter, it is not my problem."

In order to further inform the social marketing campaign, a number of messages were tested. These have similar themes to the statements in Table 5 but are phrased more closely to campaign messages and asked if the messages would encourage people to stop littering. Table 5 lists these messages in order of agreement, with the most number of respondents strongly agreeing that:

- "litter harms our marine life;"
- "litter pollutes our beaches and ocean;" and
- "when you litter, you disrespect our island and our culture"

would convince them to stop littering. Only one message had a higher number of respondents disagreeing with it: "Would you like it if someone littered in your backyard? Don't litter at the beach!", indicating that messages in this vein would not be advised for the campaign.

In all, the results indicate substantial recognition of coral reefs and their importance to recreation and Saipan's economy. Saipan residents are supportive of management measures to improve the health of coral reefs, with the exception of limiting dive tourism.
